- it is not funnily a long ago already.

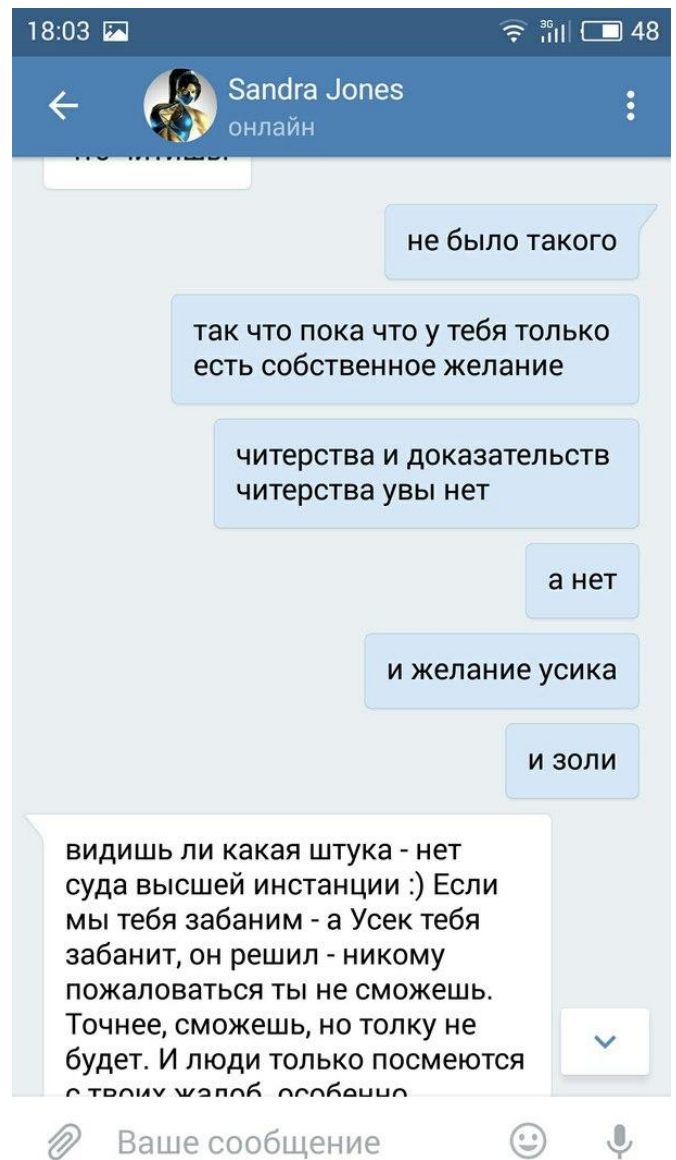
